CEPC SPONSORSHIPS

MONTHLY PROGRAM SPONSORSHIP - \$4,500

This year, we are planning to schedule as follows :

- 3 Virtual programs
- 2 In-person Breakfast programs
- 5 In-person Lunch programs

These programs will be held at The University Club of Chicago. Assignment of a monthly program is done by a 'lottery' system. Each Sponsor will be emailed a schedule of the upcoming Monthly Program Schedule (dates, topics, speakers) and the sponsor lists the order of preference for each topic using 1-10 (1 being most preferred).

WORKSHOP PROGRAMS - \$1,500

CEPC schedules at least four (4) quarterly Workshops on various topics.

FUNDAMENTALS COURSES - \$850

Each year, the CEPC presents a five-part Fundamentals Course designed to provide beginning estate planning professionals (0 - 5 years experience) with a deep introduction to the essential components of trust and estate planning and administration. In addition to junior estate planning professionals, experienced practitioners looking to bolster their trust and estate knowledge and skills are also welcome to attend.

NETWORKING EVENTS - \$1,700

Breakfast, Evening and Virtual Events are scheduled throughout the year.

In the Fall, members are encouraged to invite guests from the charitable planning community and in Spring members are encouraged to invite guests that are potential CEPC members.

There are 4-5 virtual informal 4th Friday Networking events scheduled from 8:30 - 9:15 a.m.

DIVERSITY - \$1,000

Panel discussions are scheduled throughout the year at area Universities' law, finance, business schools; Zoom Programs and Public Outreach Initiatives
